INFORMATION TO ALL POSTGRADUATE STUDENTS

TEACHING AND LEARNING ACTIVITIES FOR TRIMESTER 203
IN LIGHT OF INCREASING COVID-19 CASES AND
IMPLEMENTATION OF THE MOVEMENT CONTROL ORDER 3.0 (MCO 3.0)

1.0 BACKGROUND

- 1.1 The increase in cases of COVID-19 infection and subsequent to the implementation of the Movement Control Order 3.0 (MCO 3.0) by the government have significantly impacted the Teaching and Learning (T&L) and assessment activities at Universiti Utara Malaysia.
- 1.2 In response to this, the Management of the University has decided on several mitigation measures in line with the directives as issued by the authorities from time to time.
- 1.3 The University has decided upon the following measures to facilitate the T&L process for all postgraduate programmes for Trimester 203, which will begin on 19 May 2021.

2.0 INFORMATION AND ACTION TO BE TAKEN BY STUDENTS

2.1 Trimester 203 Academic Calendar

Academic calendar for the trimester 203 is as follows:

2.2 Re-registration for Trimester 203 Students (Student Status Activation)

- a) Students can activate their (study) status through their student portal, as per the usual practice, beginning **20 May 2020**;
- b) Students must also ensure that all outstanding tuition fees (arrears) are paid at least three (3) days before the registration date. Students will be barred from registering until the arrears are fully paid.

2.3 Implementation of Teaching and Learning Activities

- a) The University has decreed that all T&L activities will not be performed face-to-face for the duration of Trimester 203. All T&L activities will be conducted via online or remote learning method.
- b) The supervision of research conducted by Masters and PhD students (thesis, dissertation, and research paper) will also be fully conducted online.
- c) The usage of laboratories at the respective Schools by Master and PhD students is also prohibited for the duration of MCO 3.0.

2.4 Mixed Mode and Full Research Students

The assessment procedure for thesis, dissertation, and viva voce will be conducted as usual. However, due to the MCO 3.0 restriction, the viva voce sessions shall be conducted online.
